

GUIDELINES ON STUDENT / DEPENDENT PASS CANCELLATION (CHECK OUT MEMO)

- 1. Malaysian Immigration Department & Ministry of Higher Education (MoHE) require all international students to cancel the student pass and return to home country for the following category:
 - a. Graduated/Completion of Study (Name is approved for completion in Senate Meeting)
 - Deferment UG students defer for 3 semester and PG students defer for 2 semester
 - c. Withdrawal
 - d. Termination of studies/Dismissal
 - e. PG students who want to change mode from full time to part time student
- 2. Cancellation of your student pass means clearing your name and data in the Malaysian Immigration system. A Check Out Memo (COM) will be issued by the Kelantan State Immigration Department upon cancellation.
- 3. Leaving Malaysia without a proper cancellation of student pass/visa can results your name blacklisted to enter Malaysia in the future by the Malaysian Immigration Department. If the student intends to apply for another institution or secure a job in Malaysia, you will be at disadvantaged.
- 4. Cancellation of student / dependent pass need to be done at the State Immigration Department who issuing the student pass for student's data clearance by submitting the original passport and others required documents. Student need to be physically present in Malaysia.
- 5. The application for student / dependent pass cancellation need to be done THREE WEEKS prior to flight departure by submitting the required documents as follows to UMK International:
 - a. Visa Cancellation Form;
 - b. Original passport with a minimum of 5 blank Visa pages, a copy of data page & student pass page;
 - c. Flight ticket to your home country / Employment letter / Offer Letter from other university;
 - d. Clearance Letter from UMK;
 - e. Completion letter / Release letter / Termination letter / Withdrawal letter.
- 6. Student's with a job offer need to cancel the student pass, return back and wait the employment process at their home country. If no cancellation is done for the student pass, your future employer cannot proceed and the employment pass application process will be put on hold as your student pass data is still active in the Immigration system. In Malaysia, foreigners are only eligible to have one type of pass at a time. You may email us for further information and clarification.
- 7. Student's dependent also need to be cancel their dependent pass.
